ARTICLES OF INCORPORATION OF  
NORTH DAKOTA ASSOCIATION OF  
STUDENT FINANCIAL AID ADMINISTRATORS

We, the undersigned natural persons of the age of eighteen years or more acting as incorporators of a corporation organized under the North Dakota Non-Profit Corporation Act, adopt the following Articles of Incorporation for said corporation:

ARTICLE I. NAME

The name of the corporation shall be: North Dakota Association of Student Financial Aid Administrators.

ARTICLE II. PURPOSES

The corporation shall be organized as a business league within the meaning of section 501(c)(6) of the Internal Revenue Code. Within this general limitation, the specific purposes of the corporation shall include the following:

- A. To promote professional growth in the area of financial aids.
- B. To provide a cooperative association of people directly related to student financial aids and to promote communication between these people.
- C. To better serve the needs of students through closer cooperation between institutions and those involved in administering financial aid programs.
- D. To stimulate a greater interest in the area of financial aids.
- E. To assure that the financial aid facet of student personnel work is understood by and in cooperation with the areas within student personnel.
- F. To encourage research within the profession.
- G. To encourage better communication between financial aid administrators of post-secondary educational institutions and those in areas related to the profession such as high schools, parents, other financial aid granting institutions including banks, savings and loan associations and others.
- H. To encourage financial aid officers to become involved with related fields.

### ARTICLE III. PERIOD OF DURATION

The period of its duration shall be perpetual.

### ARTICLE IV. LIMITATIONS

This corporation is not organized for profit and shall have no capital stock. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance to the purpose set forth in Article II above.

The members and directors of this corporation shall not be personally liable for the payment of any debts or obligations of this corporation to any extent whatsoever.

### ARTICLE V. REGISTERED OFFICE AND AGENT

The address of the initial registered office of the corporation is c/o State Board of Higher Education, State Capitol, Bismarck, N.D. 58505-0514.

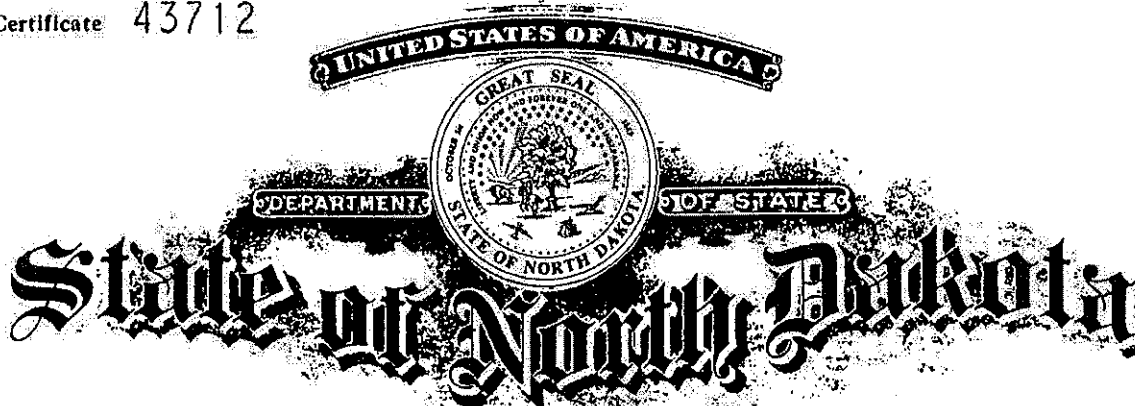
